Information you'll need to assemble

- **Vital Statistics**

-This includes information such as your father's name, your mother's maiden name, your level of education, your place of birth, and your social security number.

- **Affiliations**

-This includes fraternal, sorority, or union membership, along with any special recognitions you might have.

- **If you are a veteran, you'll also need to include:**

-Military service

-Branch

-Date of enlistment

-Date of discharge (**DD214 form from enlisted branch of the military**)

-Name(s) of war/conflict(s) toured

-Serial number

Ways in which you can plan ahead:

General

- Gather personal information for your obituary
- Choose a funeral home
- Choose a charity for donations, if desired
- Make a note of any special instructions you desire for your services and final dispositions

Funeral Service

- Choose a burial or cremation
- Select a casket or cremation or cremation container
- Choose the location and type of service
- Choose a floral arrangement or casket spray
- Decide whether you'd like to have a viewing or visitation
- Select photos or memorabilia you'd like displayed
- Consider any customs, traditions, or religious rites that are important to you and your family
- Select choice of music to be played at service

Participants

- Choose a clergy or officiator to preside over the service
- Select musicians whose talents you'd like to employ
- Select pallbearers and flower ladies
- Choose clergy, friends, or family members to perform the eulogy, read scripture, or prepare a speech

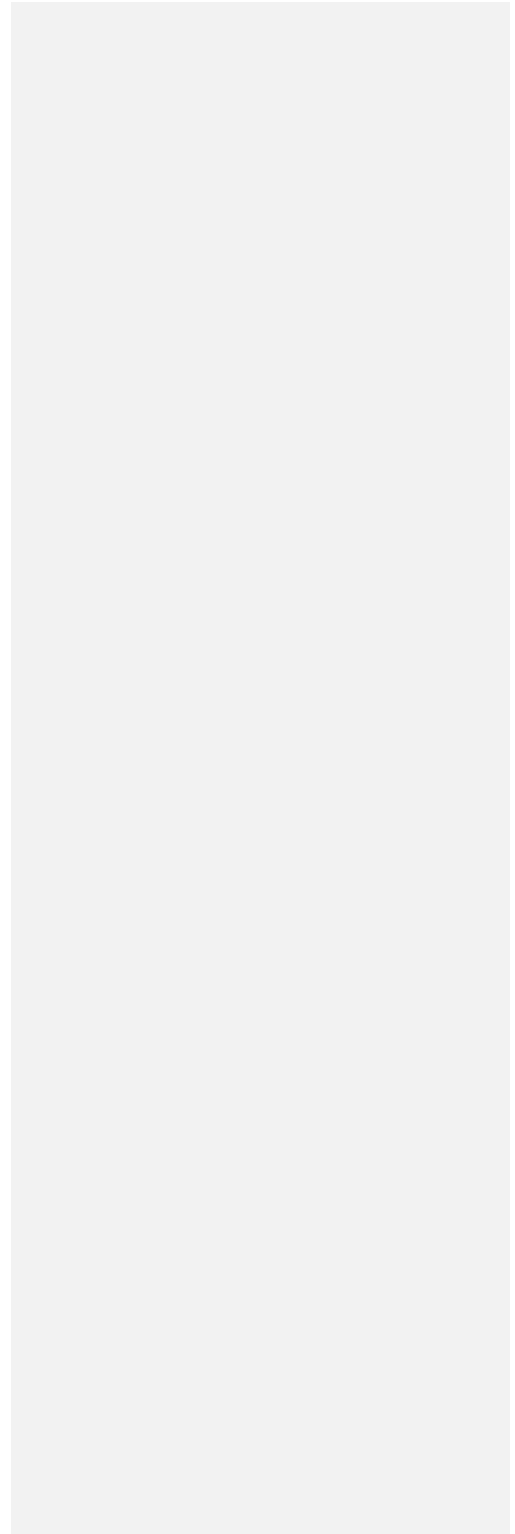
